As you are aware, the above named tenant(s) are putting you forward to stand Guarantor for them and the agreement they are shortly proposing to enter into. We are writing to you to ensure that before committing yourself to signing the Guarantor Agreement, you fully understand what might be expected of you as a Guarantor.

You will be undertaking to make good any shortfall in the tenant's payments, both normal ongoing payments and any arrears as they might accrue. You are also guaranteeing the tenant's obligations with regard to the satisfactory condition of the property, both during the tenancy and also when they vacate the property and it is returned to us.

In short you are basically standing in the tenant's shoes as far as their commitment is concerned. These are considerable responsibilities and should not be entered into lightly, though if you are satisfied that the tenants will meet their obligations then at this stage there is relatively little to worry about. The Guarantor Agreement creates a binding legal contract. If you do not fully understand the nature of the agreement, then it is recommended that you take legal advice on the matter, either through your own legal representative or via the local Citizens Advice Bureau, before signing and entering into this agreement.

We request you complete an application form for referencing purposes on the same basis as if you were going to occupy the property yourself. This is standard procedure, since of course if you are standing as Guarantor for the tenant's commitments it is only right that your own capacity to service that commitment is assessed in the same way as the tenant. Delay or failure to return these forms will mean the tenants cannot take up occupancy.

The Guarantor signatory section of the agreement must be signed and witnessed and returned to us as soon as possible (no later than the tenancy papers are signed by the tenants and the tenancy actually commences).

If you have any queries regarding these procedures please do not hesitate to contact us, otherwise we look forward to receiving the Guarantor's application form soon.
