Tenant Find	Maximum 120% including VAT of the first months rental income (maximum of 100% + VAT)
Tenant Find Plus	Maximum 120% including VAT of the first months rental income (maximum of 100% + VAT) plus 3.6% including VAT (3% + VAT) of the monthly rental income thereafter
All Inclusive Fully Managed Fee (No Set Up Fees)	Maximum of 18% including VAT of the monthly rental income (maximum of 15% + VAT)
All Inclusive Fully Managed Plus (No Set Up Fees)	Monthly fee of £25 inclusive VAT (up to £1000 pcm) or £30 inclusive VAT (rents above £1000 pcm). This fee is payable in addition to the Fully Managed Service fee specified above.
