# Dear Prospective Guarantor

Re: Request to act as Guarantor for (Tenant name(s)):

As you are aware, the above named Tenant(s) are putting you forward to stand Guarantor for them and the Agreement they are shortly proposing to enter into. We are writing to you to ensure that before committing yourself to signing the Guarantor Agreement, you fully understand what might be expected of you as a Guarantor.

You will be undertaking to make good any shortfall in the Tenant's payments, both normal ongoing payments and any arrears as they might accrue. You are also guaranteeing the Tenant's obligations with regard to the satisfactory condition of the property, both during the Tenancy and also when they vacate the property and it is returned to us.

Effectively, you are standing in the Tenant's shoes as far as their commitment is concerned. These are considerable responsibilities and should not be entered into lightly, although if you are satisfied that the Tenants will meet their obligations, then at this stage there is relatively little to worry about. The Guarantor Agreement creates a legally binding contract. If you do not fully understand the nature of the Agreement, we recommend that you take legal advice on the matter, either through your own legal representative or via the local Citizens Advice Bureau, before signing and entering into this Agreement.

Please complete an application form for referencing purposes on the same basis as if you were going to occupy the property yourself. This is standard procedure - as you are standing as Guarantor for the Tenant's commitments, it is only right that your own capacity to service that commitment is assessed in the same way as the Tenant. Delay or failure to return these forms will mean the Tenant cannot take up occupancy and may lose their Holding Deposit.

The Guarantor Signatory section of the Agreement must be signed and witnessed and returned to us as soon as possible but prior to the Tenancy Agreement itself being signed.

If you have any queries regarding these procedures, please do not hesitate to contact us. Otherwise, we look forward to receiving the completed Guarantor's Application form as soon as possible.

# Guarantor Agreement

If the Tenant(s) defaults in the performance of any observance and obligation of any of the provisions contained in the Tenancy Agreement then the Guarantor hereby indemnifies Bassets Property Services Ltd and the Landlord(s) against all loss, damage, expenses or costs incurred by reason of the Tenant(s)' non-performance.
3. This Guarantee shall continue throughout the period that the Property is occupied by the Tenants or their licensees and is not limited to the term specified in the Tenancy Agreement referred to above.
4. During this period, as referred to in clause 3, this Guarantee shall not be revocable by the Guarantor, nor will it be rendered unenforceable by the Guarantor's death or bankruptcy.
5. This Guarantee is not discharged, by Bassets Property Services Ltd allowing the Tenant time in which to meet any rent or discharge any other failing in respect of the Tenancy Agreement and for which, under the terms of this Guarantee, the Guarantor may be held liable.
6. I confirm that I understand the terms and conditions of this Guarantee, having taken whatever advice I deem prudent with regard to the obligations to which the Agreement commits me.
